\*\* Effective for all hours worked after June 1, 2018 a **vacation fund** has been approved by members of Local 11, Area 362. This is an “after tax” deduction from members payroll check. Contractors are to **deduct** \$5.00 an hour for **straight time** hours (\$7.50 for hours worked at **time and one half**, and \$10.00 per hour for **double-time** hours) to be submitted to our administrator along with the normal pension and welfare benefits.

**APPRENTICE BASE WAGE RATES & BENEFITS:**

1<sup>st</sup> Year Apprentice = 70% Journeyman Wage (\$31.78) + Journeyman Benefits; *No Sav/Vac* Local Dues \$2.03; Int'l Dues \$0.68  
 2<sup>nd</sup> Year Apprentice = 80% Journeyman Wage (\$36.32) + Journeyman Benefits; *No Sav/Vac* Local Dues \$2.17; Int'l Dues \$0.72  
 3<sup>rd</sup> Year Apprentice = 90% Journeyman Wage (\$40.86) + Journeyman Benefits; + Sav/Vac Local Dues \$2.30; Int'l Dues \$0.77
