Please be advised that there will be an adjustment to the wage package for the **PLASTERERS** of **LOCAL 11 AREA 362** (Lake County) effective **JUNE 1, 2022**, extending through **MAY 31, 2023**.

** Effective for all hours worked after June 1, 2021 a **vacation fund** has been approved by members of Local 11 Area 362. This is an “after tax” deduction from members payroll check. Contractors are to **deduct** \$5.70 an hour for **straight time** hours (\$8.55 for hours worked at **time and one half**, and \$11.40 per hour for **double-time** hours) to be submitted to our administrator along with the normal pension and welfare benefits.

APPRENTICE BASE WAGE RATES & BENEFITS:

1st Year Apprentice = 70% Journeyman Wage (\$34.06) + Journeyman Benefits; *No Sav/Vac* Local Dues \$2.23; Int'l Dues \$0.74
 2nd Year Apprentice = 80% Journeyman Wage (\$38.92) + Journeyman Benefits; *No Sav/Vac* Local Dues \$2.37; Int'l Dues \$0.79
 3rd Year Apprentice = 90% Journeyman Wage (\$43.79) + Journeyman Benefits; + Sav/Vac Local Dues \$2.52; Int'l Dues \$0.84
