\* Effective June 1, 2022 the rate of contribution for the Tax Deferred Income Fund will be \$16.20 for *straight time* hours worked; \$24.30 for all hours worked at *time and one half*; and \$32.40 for all hours worked at *double-time*, which is to be submitted to the administrator with the above listed fringe benefits.

1<sup>st</sup> Year Apprentice = 70% Journeyman Wage (\$33.39) + Journeyman Benefits; LD \$2.40; ID \$0.80; BF \$0.21  
2<sup>nd</sup> Year Apprentice = 80% Journeyman Wage (\$38.16) + Journeyman Benefits; LD \$2.55; ID \$0.85; BF \$0.24  
3<sup>rd</sup> Year Apprentice = 90% Journeyman Wage (\$42.93) + Journeyman Benefits; LD \$2.69 ID \$0.90; BF \$0.27

\*\*\* Overtime rates are as follows: Double the regular rate of pay during the week (Monday through Friday) **and time and one half the regular rate of pay on Saturdays.**

**REMINDER:** Any Cement Mason who is discharged or laid off shall be paid by cash or check in person or by mail postmarked within 48 hours to the nearest working day. In the event an Employer does not send the check promptly postmarked within 48 hours to the nearest workday, a 4 hour penalty shall be assessed for each day postmarked after the initial 48 hours, payable directly to the affected Cement Mason, and the Union reserves the right to deny the said Employer privilege of mailing future check.
