In the event an Employer does not send the check promptly postmarked within 48 hours to the nearest workday, a 4 hour penalty shall be assessed for each day postmarked after the initial 48 hours, payable directly to the affected Cement Mason, and the Union reserves the right to deny the said Employer privilege of mailing future check. Please see Section 3, Paragraph 8, for further explanation.

<sup>\*\*</sup> Effective for all hours worked after June 1, 2023 a **Savings/Vacation Fund** has been approved by members of Local 11 Area 362. This is an "after tax" deduction from members' payroll check. Contractors are to **deduct** \$9.20 8an hour for *straight time* hours (\$13.80 for hours worked at *time and one half*; and \$18.40 per hour for *double-time* hours), which is to be submitted to the administrator along with the above listed fringe benefits.
